- Kitsap County Transportation Advisory Council has a new subcommittee that will focus on a County Non-Motorized Trail Plan, they need volunteers
- Indianola Trails Connection Meeting Thursday May 22, 2008 at 7 p.m.
- Update on RWIP
 - Revisions have been made and given to the Hearings Board
 - Need conversations with Tribes/Community regarding the official changes to RWIP
- Port of Eglon should be their own pearl - OPG met with this community and has extended the invitation to participate - haven't heard back yet
- OPG has done several outreach meetings for surrounding communities
- Paddle Kitsap-www.paddlekitsap.com
 - Aug 1 & 2
 - Over 100 registered so far
- Organizational Development Update
 - The draft of the 501(c)3 is completed and was given to OPG for review
 - There needs to be a meeting with the Organizational Development Committee, Tom Schroeder, and OPG to review 501(c)3 - Linda to set up meeting
- Reminder for people to log their volunteer hours
 - Can submit on www.nkstringofpearls.com or e-mail Sue Schroeder
 - Dave Haley would like to know if his committee is putting in their hours, Sue to send him the matrix
- The Technical Assistance Committee met with a representative from Triad Associates to review GIS information, main idea is to keep everything in the same format
- S'Klallam tribe was awarded federal money for trails and is working with the National Park District, Tom Curley to e-mail map of trails to Sue Schroeder

II. Field Work and Mapping

- Poulsbo
 - Primary route is to get from Poulsbo to OPG property
 - Started to work on a route from Noll Road along Bill Arness's property up to Lincoln Road
 - Second route is to get from Poulsbo to Suquamish
 - One problem is that some of the properties have multiple owners
 - Linda Berry Maraist has been talking with Tex Lewis from the Clear Creek Trails
 - Alternative route is from Fish Park through the wetlands to Dog Fish Creek to Bond Road and up Big Valley Road
 - There are multiple routes out of Poulsbo Trail Committee is still working on finding feasible routes
- Suquamish
 - Working on a route from the casino to downtown Suquamish

- The Tribe is focused on eco-tourism
- Division Street has funding in 2011 for one sidewalk
- Indianola
 - Dave Haley presents Greater Peninsula Conservancy master plan for trails
 - Would like to get a waterfront preserve
 - Already have existing trails that will remain
 - June 11, 2008-11 a.m. Indianola Trails Committee is walking County right-of-ways to determine trail links
 - Greg Cioc's point of contact for County right-of-ways is Sheryl Schroeder
- Kingston
 - Port Gamble/Suquamish road is narrow, steep and has wetlands-not recommended for a trail connection
 - Carolina Veenstra and the trail committee has checked numerous areas of interest
 - Elizabeth Wilson is working on finding easements surrounding part of OPG lands (The Divide Property)

 - John Hawkins to coordinate some volunteers to start on trail maintenance or trail creation to celebrate National Trails Day
- The Great Peninsula Future Festival August 2-3, 2008
 - Volunteers are needed to run a booth for the NKTA

- Dave Haley and Carolina Veenstra need 24X36 Indianola/Kingston map
